**Action:** More publicity around the tracking of the complaints.

Total of 20 complaints have been logged since the last AGM.

Of these, total of 17 have been substantiated.

15 complaints were regarding venues/artists who are not subscribers.

Of the complaints regarding non-subscribers, 8 had no action and were merely logged.

In 5 complaints concerning non-subscribers, the committee took official action, namely conversations and formal letters where warranted.

Of the 4 complaints made against models, 2 were historical and no action was taken. One was partially substantiated and resulted in an informal conversation, and one is still being investigated.

The 1 complaint made against a subscriber was actioned by the complainant. The Committee will monitor the situation and will get involved if and when they are needed.

5 complaints were regarding underpayment of the new rate, 4 were breaches of other working conditions including heating, toilet as changeroom, photography without consent, and payment for double booking. 6 involved inappropriate behaviour, and 2 were flaky bookings.
